## Seasonal Maintenance Worker

**Hourly Salary Range (non-exempt): \$18.00 – \$23.00 dependent on experience and qualifications**

This position is a temporary, seasonal, non-exempt role (employee is eligible for overtime in accordance with Federal Fair Labor Standards Act, State Minimum Wage Act); it is not eligible for State PERS retirement or other District benefits.

The scope of work for this position entails regular and recurring installation, repair, and maintenance work in the District's water and sewer systems under frequent supervision. Specific duties include but are not limited to:

- Installs, services and repairs District water and sewer facilities; including but not limited to water and sewer mains, pruning, mowing, and manual landscaping.
- Washes and cleans District vehicles and equipment.
- Assists in the installation, repair and maintenance of valves, water meters, and fire hydrants.
- Services and maintains small tools and equipment.
- Provides traffic zone control (flagging) as required.
- Works with other District staff to perform service disconnection, water meter lock outs, and reconnections.
- Operates vehicles, small tools and other equipment.
- Able to be assigned to and respond to off-hour emergency response work.

**Required Qualifications:**

- Age 18 years or older.
- High School Diploma or GED.
- Physically able to perform essential functions, including light lifting and carrying.
- Valid Washington state driver's license and driving record acceptable to the District.
- Able to conform to work site safety regulations and procedures during field operations.
- Able to use Microsoft Word, Excel, and Outlook.
- Legally able to work in the United States and successfully pass a background investigation.
- Able to understand, read, speak and write English.
- Fully vaccinated against the COVID-19 virus.

**Preferred Qualifications:**

- Excellent communication skills.
- Able to follow oral and written directions.
- Able to exercise discretion, courtesy, and patience with all District customers.
- Able to work up to 40 hours per week, Monday through Friday, with some flexibility in scheduling, including the ability to work overtime if needed.
